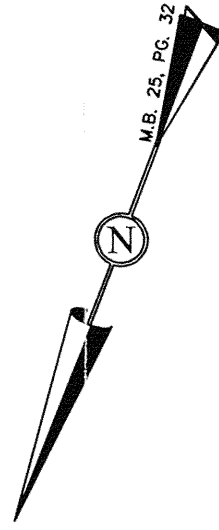


VICINITY MAP

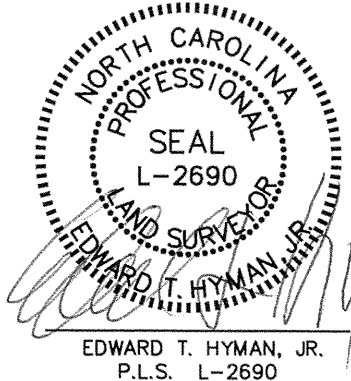

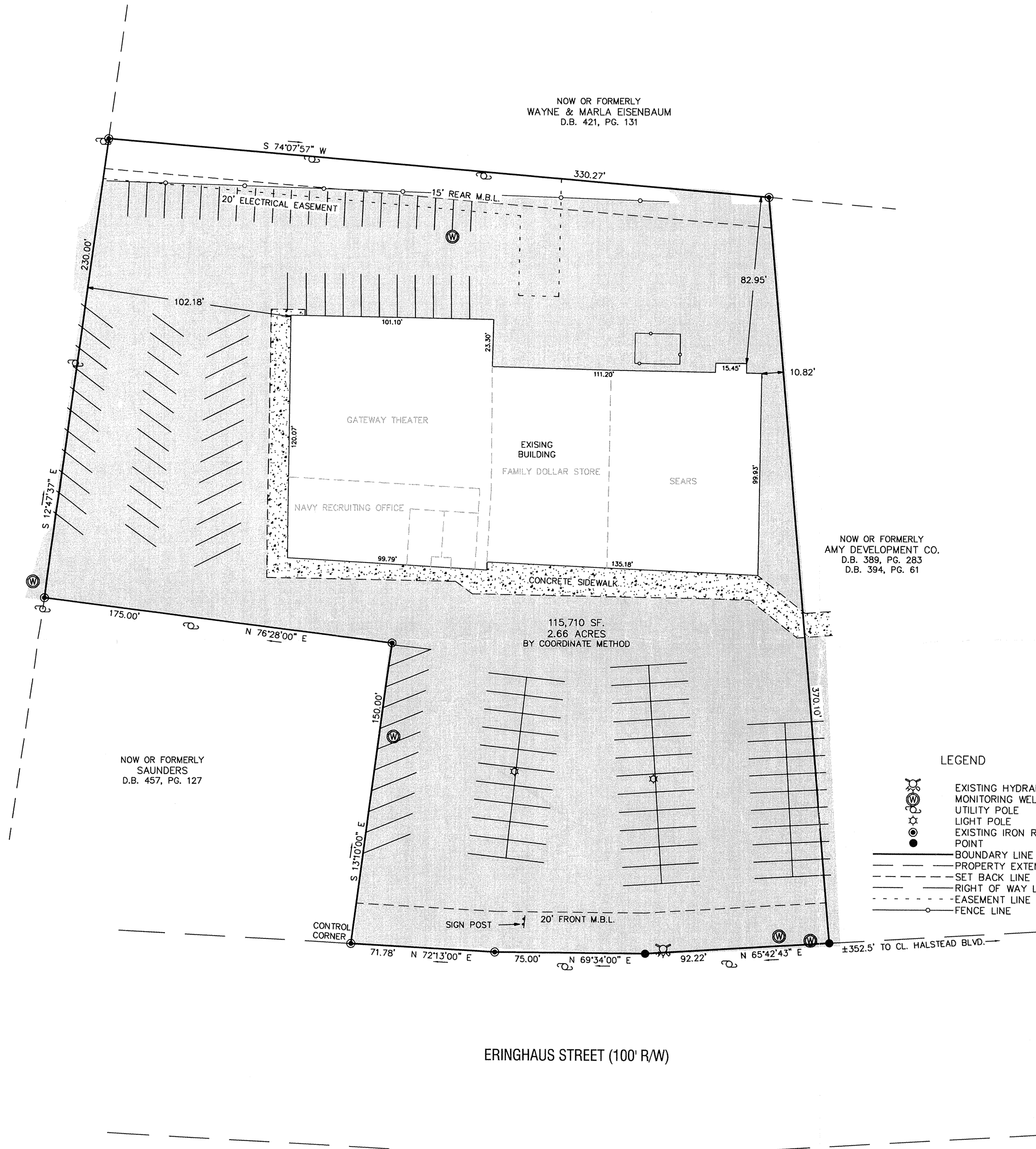

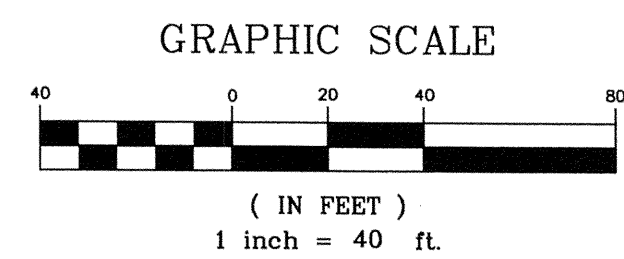
